

# COOPERATION AGREEMENT

BETWEEN

1. Faculty of Education in Jagodina, University of Kragujevac, Milan Mijalkovic 14, 35000 Jagodina, Republic of Serbia, represented by dean Violeta Jovanovic, full professor, and
2. University of Primorska, Faculty of Education, Cankarjeva 5, SI – 6000 Koper, Republic of Slovenia, represented by dean Mara Cotič, full professor.

Cooperation agreement is concluded for the following period: from February 2017 till September 2019, during which scientific bilateral project will be realised.

Subject of the project: Assumptions and possibilities of developing innovative models of teaching in the function of accomplishing transparency of university education and raising the competitiveness in the national and international market of knowledge.

Institutions – the parties involved in the Project:

1. Faculty of Education in Jagodina, University of Kragujevac, Milan Mijalkovic 14, 35000 Jagodina, Republic of Serbia, represented by dean Violeta Jovanovic, full professor, and
2. University of Primorska, Faculty of Education, Cankarjeva 5, SI – 6000 Koper, Republic of Slovenia, represented by dean Mara Cotič, full professor.

## Article 1.

The project will be realised under the following conditions:

1. The associates in the Project from both Faculties will realise all the tasks by prior arrangement about the way of realization and the time schedule of the activities;
2. In case of the need for eventual deviation from the planed Project, each party will timely inform the other party involved;
3. According to the determined programme, the Project will be realised through several phases, from the theoretical consideration of the problem through the appliance of innovative teaching models up to their evaluation;
4. The results of the conducted research in this matter will be published in agreement with both parties.
5. Both parties are obliged to exchange information about the activities realisation in the Project.

6. Publishing costs of the scientific papers made as the result of the Project will be beard by both parties according to the internal agreement;
7. Travel costs of the associates involved in the Project will be beard by the Faculty where they are employed, and their accommodation costs will be payed according to the agreement made by both parties.

### Article 2.

This agreement contains the most significant elements of cooperation, and both parties can complement or change it with mutual consent in case it is needed due to altered conditions.

### Article 3.

This agreement is made in four copies in English and each party will possess two copies of it.
